1. GENERAL INFORMATION

1.1 Terms and conditions

The fees invoiced by Flughafen Niederrhein GmbH (FN) are net fees for which the applicable statutory value-added tax must be paid in addition, unless VAT exemption applies. Whether or not VAT exemption applies depends on the invoice recipient.

The Airport User Regulations for FN, as amended from time to time, are an integral part of the Schedule of Fees.

The services listed below (special services) will be provided upon request, provided that the prerequisites for this are met and personnel, equipment and vehicles can be made available in each case. Pending contractual obligations to the contrary, there is no legal claim to the provision of these services. Even after possible acceptance of an order, FN reserves the right to freely dispose of personnel, equipment and vehicles during the performance of special services. Provided services and deliveries not included in this list will be charged separately.

The minimum calculation unit for special services is the calculation unit stated. Units or parts thereof shall be invoiced.

If, in the case of the provision of equipment and vehicles, it is not expressly stated that the price includes the provision of the operator or driver; the deployment of personnel shall be charged separately.

If airlines or other companies operating at the airport make use of individuals and/or services of FN within the scope of the provision of personnel, the personnel costs shall be charged per hour or part thereof.

1.2 Exclusion of liability and indemnity

Where assistance is provided, FN as well as its employees shall not assume any liability for the items processed or transported, unless damage was caused intentionally or by gross negligence.

Claims for compensation for all damage caused to the processed item in connection with a special service order are excluded, unless the damage was caused intentionally or by gross negligence. FN as well as its employees shall be indemnified against corresponding claims for damages by third parties.
